## 1st Muizenberg Rover Crew Charter

We, the Rover Crew of 1st Muizenberg, being members of SCOUTS South Africa, commit ourselves to the following Charter, in order to promote the aims and objectives of the Scouting Movement and to further our own personal development.

**Article 1 - Name and Affiliation:** This Rover Crew shall be known as the 1st Muizenberg Rover Crew and shall be affiliated to SCOUTS South Africa.

**Article 2 - Objectives:** The objectives of the 1st Muizenberg Rover Crew shall be:

- a. To develop our character, knowledge and skills in accordance with the principles of the Scouting Movement.
- b. To provide service to the community.
- c. To promote and uphold the Scout Law and Promise.
- d. To foster inter-branch and inter-Group understanding and co-operation.
- e. To promote youth development through outdoor adventure.

**Article 3 - Membership:** Membership of the 1st Muizenberg Rover Crew shall be open to all persons 18 years and older, who have been invested as Rovers in accordance with the procedures of SCOUTS South Africa. An annual Membership Fee will be charged. This Membership fee will be determined at the Rover Crew AGM.

**Article 4 - Organisation:** The 1st Muizenberg Rover Crew shall be organised in accordance with the policies and constitution of SCOUTS South Africa.

**Article 5 - Meetings:** The 1st Muizenberg Rover Crew shall meet regularly at a time and place to be determined by the Crew, this will include formal meetings, socials, and outdoor activities.

**Article 6 - Finance:** The 1st Muizenberg Rover Crew shall raise funds and manage its finances in accordance with the procedures of SCOUTS South Africa. Rover funds will be conducted through the 1<sup>st</sup> Muizenberg Group Account and be managed by a Rover Treasurer who will liaise with the Group Treasurer.

**Article 7 - Amendments:** This Charter may be amended by a two-thirds majority of the members of the 1st Muizenberg Rover Crew present and voting at a properly convened meeting.
